BACKGROUND

Mahala Faulk was born 26 October 1828¹ in Alabama.² She married James Fowler on 8 January 1844 in Pike County, Alabama.³ Many family trees state Mahala's parents were Philip Faulk and Elizabeth Soles, citing a biological sketch in *Notable Men of Alabama, Volume 1* for Joseph Warren Harris, the son of Philip and Elizabeth's daughter Mary Ann.

The purpose of this research project is to prove or disprove Mahala Faulk Fowler was the daughter of Philip Faulk and his wife Elizabeth of Pike County, Alabama.

ANALYSIS OF JOSEPH WARREN HARRIS BIOGRAPHICAL SKETCH

A biographical sketch of Joseph Warren Harris appears in Joel C. DuBose's *Notable Men of Alabama, Volume 1.* The sketch includes much information about Harris's Faulk family, including a maiden name for Philip Faulk's wife Elizabeth, a timeline of their migration from North Carolina, and birthdates for Philip Faulk and his children.⁴

Harris's descent from Philip and Elizabeth Faulk can be verified by census enumerations and his parents' marriage record,⁵ but the biographical sketch does not provide sources for the Philip Faulk family information.

Both volumes of *Notable Men* are biographies of living Alabama political figures with DuBose credited as editor. The sketches were likely submitted by the featured men or were published with their knowledge. Therefore, the information in Harris's sketch was probably written by Harris who would have heard his Faulk family history from his mother. Harris's biography also includes a photograph, further suggesting he was the informant.

Most interestingly, the sketch contains specific birthdates for Philip Faulk and his children—information not included for Harris's paternal family. It is doubtful Harris memorized and included the birthdates of his Faulk grandfather, aunts, and uncles but not his Harris family. This information may point to the existence of a Faulk family Bible as a source for Harris's sketch. Such Bible records have not been found for the Philip Faulk family.

COURT RECORDS

In the absence of Bible records confirming relationships in the Harris sketch, Pike County court records were searched for documents stating a relationship between Philip and Elizabeth Faulk and Mahala Faulk Fowler.

Probate Records

Philip Faulk resided in Pike County, Alabama, from at least 1830 through 1860;⁶ he also patented land in the county.⁷ No will or probate case files for Philip Faulk were found in Pike County.

Deed Records

Philip Faulk did not conduct any Pike County land transactions with Mahala and her husband James Fowler, but Philip did sell land to two sons:

Twelve years earlier, Philip was indebted to Parker & White Merchants of Montgomery County, Alabama, for \$130; the indenture was recorded in Pike County on 8 Dec 1840.⁸ Settlement of the debt was not recorded, so it is likely Philip lost the pair of oxen used as collateral.⁹ Although these events occurred years apart, they may show Philip was of meager means and did not have property or possessions to warrant an estate settlement recorded by the court. A widower with adult children and no property, Philip may not have generated probate records.

CENSUS RECORDS

Philip Faulk and his household are easily found on US census records from 1830 through 1860, with the migration information provided in the Harris biographical sketch. Pre-1850 censuses only list the name of the head of the household; all other household members are reported as totaled numbers in male and female age ranges. Did a female Mahala's age live in the Philip Faulk household in 1830 and 1840? Do the Philip Faulk households from these censuses contain members whose ages match the reported birthdates from the Harris biographical sketch?

Females in the correct age range for Mahala exist in the Philip Faulk household for both 1830 and 1840 censuses. The 1840 census enumeration aligns with reported birthdates for Faulk family members. The 1830 census has some mismatches, but these discrepancies can be explained by sons Timothy and William being a few months from birthdays which would have placed them in a higher age bracket. Even correcting for these errors, an additional male not identified in the Harris biographical sketch resides in the 1830 household in either the 10-14 or 15-19 age range. This male could be another child of Philip and Elizabeth, or he could be an extended family member, boarder, or hired worker. It may also be an error by the census enumerator during data collection or transcription.

Census records throughout Mahala's later life report her birthplace as Alabama. Were there other households in Alabama with females in her age range for the 1830 and 1840 censuses? Could these females be Mahala? A list of Faulk households in Alabama was compiled for both census years and the number of females in Mahala's age range was noted:

Of the two Faulk households in Alabama in 1830, only the Philip Faulk household in Pike County contained females in Mahala's age range. In 1840, two Faulk households in Alabama contained females in Mahala's age range: the Philip Faulk household in Pike County and the H Faulk household of Barbour County.

OTHER OBSERVATIONS

Additional findings recorded during this research project suggest the Harris autobiographical sketch is accurate.

Matching Birthdate in James Fowler Family Bible

Vital records entered by Mahala's husband James Fowler in their family Bible cite Mahala's birthdate as 26 Oct 1828.¹⁰ This date matches the Harris biographical sketch. Entries in the Fowler Bible were probably made sometime between its publication date (1859) and the date of the final entry (1887). Therefore, Mahala's birthdate was likely recorded by her husband while she was alive and able to provide an accurate date.

Although the birthdates recorded in the Fowler Bible and in the Harris sketch are both secondary information, they most certainly came from independent sources: Mahala in Louisiana during the late 1800s for the Fowler family Bible and an undetermined source, perhaps a Faulk family Bible, in Alabama in 1904, for the sketch. The agreement of these dates boosts the credibility of the Harris biographical sketch as an accurate summary of Faulk family history.

Another Faulk in Jackson Parish, Louisiana

By 1860, Mahala and husband James had moved their family to Louisiana; they appear in Brooklin, Jackson Parish, in that year's census.¹¹ W. W. Faulk and his family appear in Vernon, Jackson Parish.¹² The description of W. W.—born about 1820 in North Carolina, with a wife and children born in Alabama¹³—matches the William Warren Faulk described in the Harris biographical sketch.

James Fowler and William W. Faulk also patented land about three miles apart:

It is possible James and Mahala Faulk Fowler migrated with Mahala's brother William W. Faulk to Jackson Parish or one of the households joined the other based on their family connection.

CONCLUSION

No record explicitly states Mahala Faulk Fowler was the daughter of Philip Faulk. Like other Pike County, Alabama, marriage records of this time, Mahala and James Fowler's marriage license does not include vital statistics for the bride and groom. The record also does not include witnesses. Mahala married in 1844; therefore, she never appeared by name in a census within her father's household. Philip Faulk, an elderly

widower without property, did not have a will or estate probated in Pike County court after his death. Neither did Philip buy or sell land with Mahala's husband James Fowler, implying a family relationship indirectly.

Without primary sources providing clues to Mahala's family of origin, an authored source was analyzed for its reliability and completeness. Information about the Philip Faulk family included in the biographical sketch of Joseph Warren Harris appears accurate. The specificity of birthdates within the sketch suggests its source was a now-lost Faulk family Bible. Mahala's birthdate within this sketch matches her birthdate as recorded in her husband's family Bible. The sources were most certainly independent: the Fowler Bible record was written in the late 1800s in Louisiana, and the biographical sketch was prepared in Alabama in 1904. The Harris biographical sketch also includes specific information about the Faulk family's migration from North Carolina to Alabama. The Philip Faulk household appears in the 1830 census in Lowndes County, Alabama, and in the 1840 census in Pike County, Alabama, as the Harris sketch claimed. The 1840 Philip Faulk household structure aligns exactly with reported birthdates in the Harris sketch. The 1830 household structure has some explainable differences.

Within the 1830 census, only one of the two Faulk households in Alabama reported a female within the correct age range to be Mahala: Phillip Falk of Lowndes County. For the 1840 census, two of nineteen Faulk households reported a female within the correct age range to be Mahala: Philip Faulk of Pike County and H Faulk of Barbour County.

Mahala and her husband James Fowler moved to Jackson Parish, Louisiana, by 1860. W. W. Faulk lived within three miles of their family. His age and birthplace recorded in the 1860 census matches that of William Warren Faulk, a son of Philip Faulk and Elizabeth Soles Faulk listed in the Harris biographical sketch. His given name of William can be verified by land patents he received in 1859-60 for property in Jackson Parish, Louisiana.

Based on these facts, it is reasonable to conclude Mahala Faulk Fowler was the daughter of Philip Faulk and his wife Elizabeth.

SUGGESTED FUTURE RESEARCH ACTIONS

- Conduct extensive search for a Philip Faulk family Bible.
- Research the H Faulk household of Barbour County, Alabama; determine the identity of the female in the 10-14 age category.
